Motion was made by Commissioner Garcia to approve the canvass of votes as presented for the November 6, 2018 General Election. Motion was seconded by Commissioner Vaughan. Motion carried. Copy of canvass reports attached and made a part hereof by references.


There were several persons presented to discuss the Order Prohibiting/Regulating the discharge of firearms in the Anderson Acres Subdivision. Judge Rhoades stated the court was not going to revoke anyone's rights to the 2nd amendment. Commissioner Vaughan presented the group with a proposal that Scott Higginbotham, County Attorney had drafted for Anderson Acres. There was some discussion in regards to the proposal and Scott stated if the court adopted the order that the citizens of Anderson Acres could amend or rescind the order at any time. He stated the court is not interested in taking the rights of the citizens. It is an order that will be put in place for the protection and safety of the citizens of Anderson Acres.


