

MINUTES OF COMMISSIONERS COURT, MOORE COUNTY, TEXAS
SPECIAL CALLED, FRIDAY, JUNE 22, 2022

BE IT REMEMBERED THAT ON THIS 22nd DAY OF JUNE, 2022 there came to be held a Special Called Meeting of Commissioners Court, in the Commissioners Courtroom in the Courthouse in Dumas, Moore County, Texas. The following persons were present to-wit: Rowdy Rhoades, County Judge; Daniel Garcia, Commissioner Precinct 1; Miles Mixon, Commissioner Precinct 2; Dee Vaughan, Commissioner Precinct 3; Lynn Cartrite, Commissioner Precinct 4; and Teresa Henry, Deputy County Clerk.

Court having been opened according to law the following proceedings were had to-wit:

Motion was made by Commissioner Garcia to take principal action on agreement in regards to the Interlocal Agreement with Dumas Economic Development Corporation and place on next agenda to be approved. Motion was seconded by Commissioner Mixon. Motion carried.

Motion was made by Commissioner Garcia to take "No Action" on acknowledging certification of an assistant auditor. Motion was seconded by Commissioner Cartrite. Motion carried.

Raymond Tate, Road & Bridge Supervisor was present to report on the department. Raymond stated he has received a bid on culvert pipe at a cost of \$35.00 per foot delivered. Commissioner Garcia asked if he was purchasing extra pipe so the county wouldn't be short once they use the pipe for culverts on the Buddy Kline & Road I road project. He stated it would be to replace what they use on the road project. Raymond wanted to know who pays for the culverts. Commissioner Vaughan stated if a land owner wants a new entrance the cost of the culvert is on the land owner but if it is an existing culvert and is a maintenance issue the county would be responsible for the cost of the culvert.

Raymond had a few questions in regards to the job description for the Road Supervisor. The court marked through the part in regards to culvert permits. The court expressed to Raymond that he would need to make sure he is capable of addressing rule violations and apply disciplinary procedures in accordance with the guidelines established by the County. He assured the court he could follow the essential functions of the job.

Kara Milligan, County Treasurer stated Raymond has 84 hours comp time and it was stated he would not lose his comp time and can use it as a supervisor but he can't accumulate additional comp time as a supervisor

Raymond stated he has two applications and one was submitted in a timely manner and one that was submitted late. . He stated the one application that he has he would like to interview the person and the court stated he could to go ahead with the interview.


He would like to place another ad in the paper for the second position.

Commissioner Vaughan wanted to clarify if the road crew is still working on Road G & Road 8 and it was stated they are still working on those roads.





Commissioner Precinct 2, Miles Mixon




