BE IT REMEMBERED THAT ON THIS 8TH DAY OF APRIL, 2024 there came to be held a Regular Session of Commissioners Court of Moore County, Texas in the Commissioners Courtroom in the Courthouse in Dumas, Texas. The following persons were present to-wit: Rowdy Rhoades, County Judge; Daniel Garcia, Commissioner Precinct 1; Colt Farni, Commissioner Precinct 4 and County Clerk, Brenda McKanna.

Court having been opened according to law the following proceedings were had to wit:

Commissioners Mixon and Vaughan were absent from the meeting.

Motion was made by Commissioner Farni that the bills as presented by Coy Barton, County Auditor be approved for payment and the County Treasurer is hereby directed to issue warrant-checks thereof and approve the Temporary Cash Investments dated April 8 , 2024 as presented by Coy Barton, County Auditor and the County Treasurer's Report of Cash Disbursements of the same date and duly recorded in the Commissioners Court Minutes. Motion was seconded by Commissioner Garcia. Motion carried.

There was one bill presented for Special Handling:
Motion was made by Commissioner Farni to approve the payment in the amount of \$5,156.52 to Visiting Judge, John Board. Motion was seconded by Commissioner Garcia. Motion carried.

Motion was made by Commissioner Garcia to approve CASA 69 Child Abuse Awareness & Prevention Month April 2024 Resolution. Motion was seconded by Commissioner Farni. Motion carried. Copy of resolution attached and made a part hereof by references.

Motion was made by Commissioner Farni to approve overtime payment in the amount of \$1,025.19 to employees of the County Clerk's Office for extended election hours to be paid out of the election budget. Motion was seconded by Commissioner Garcia. Motion carried. Copy of hours attached and made a part hereof by references.

Motion was made by Commissioner Garcia to approve a road permit for Down & Dirty Ditching on County Road G in precinct 1. Motion was seconded by Commissioner Farni. Motion carried. Copy of permit attached and made a part hereof by references.

Raymond Tate, Road & Bridge Supervisor gave a report on the department. Raymond received a call-in regard to Road 28 in precinct 4. There are some farmers that would like to take the road back and maintain the road themselves. Commissioner Farni stated he does not have a problem with abandoning the road and allowing the farmers to maintain it. Raymond will visit with the County Attorney to start the process and report back to court at the next meeting.

No further action is to come before the court, motion was made by Commissioner Garcia to adjourn. Motion was seconded by Commissioner Farni. Motion carried.


