

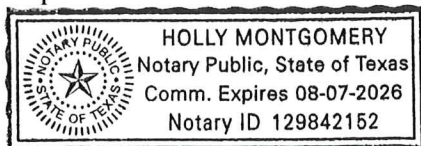

## Exhibit "A"

### Property Description

A parcel of land out of Survey 268, Block 44, H&TC Ry. Co. Survey, Moore County, Texas described as follows:

Beginning at a 1/2" rebar found in the east R.O.W line of Dumas Avenue (U. S. Highway 287) for the southwest corner and point of beginning this tract, from whence the northwest corner of the Evans Addition to the City of Dumas, Moore County, Texas bears S. 00°00'00"W. - 150.0'.
