

**MINUTES OF COMMISSIONER COURT, MOORE COUNTY, TEXAS
REGULAR SESSION, MONDAY, MAY 9, 2022**

**STATE OF TEXAS {
COUNTY OF MOORE }**

BE IT REMEMBERED THAT ON THIS 9TH DAY OF MAY, 2022 there came to be held a Regular Session of Commissioners Court of Moore County, Texas in the Commissioners Courtroom in the Courthouse in Dumas, Texas. The following persons were present to-wit: Rowdy Rhoades, County Judge; Daniel Garcia, Commissioner Precinct 1; Miles Mixon, Commissioner Precinct 2;; Lynn Cartrite, Commissioner Precinct 4; and County Clerk, Brenda McKanna.

Court having been opened according to law the following proceedings were had to wit:

Commissioner Vaughan was absent from the meeting.

Motion was made by Commissioner Cartrite that the bills as presented by James Allen, County Auditor, be approved for payment and the County Treasurer is hereby directed to issue warrant-checks thereof. Motion was seconded by Commissioner Mixon. Motion carried

There was one bill presented for special handling for approval:
Motion was made by Commissioner Cartrite to approve the payment in the amount of \$51,074.21 to Castillo Ventures with expenditure to be paid from the American Rescue Funds. Motion was seconded by Commissioner Garcia. Motion carried.

Motion was made by Commissioner Cartrite to approve the Temporary Cash Investments dated May 9, 2022 as presented by James Allen, County Auditor, and the County Treasurer's Report of Cash Disbursements of the same date and duly recorded in the Commissioners Court Minutes. Motion was seconded by Commissioner Garcia. Motion carried. Copies of the Report and Temporary Cash Investments are attached and made a part hereof by references.

Judge Rhoades declared the meeting open for a public hearing at 9:06 A.M. concerning speed reduction on Hunt County Road to 50 mph. Commissioner Garcia has been contacted by several residents on Hunt Road with concerns of the speed of the trucks on road. Commissioner Garcia is requesting the speed limit be permanently lowered to 50 mph. Bonnie Hunt asked if there could be signs posted stating Slow Down. After hearing from Bonnie Hunt and Mr. & Mrs. Taft Commissioner Cartrite stated he would like to lower the speed limit to 40 mph and install permanent speed bumps. Judge Rhoades declared the public meeting closed at 9:24 A.M. and opened Commissioners Court for routine business.

Amy Francis and Kim German representatives from Panhandle Community Service invited the court to a dinner on June 2, 2022 and they will also be inviting families from all over the county that they provide a service for. They presented information in regards to new programs that will

benefit communities in the top 26 counties of Texas. Copy of presentation attached and made a part hereof by references.

Motion was made by Commissioner Mixon to approve Elite Technologies getting Sheriff's Dept. a new back-up solution for all CJIS data with Veeam at a cost of \$500 per month with a prorate for the remainder of the fiscal year in the amount of \$2,500.00 to be paid from American Rescue Plan Funds. Motion was seconded by Commissioner Cartrite. Motion carried.

Motion was made by Commissioner Garcia to approve bids from GQ Homes LLC on numerous properties in Double Diamond Estates. Motion was seconded by Commissioner Mixon. Motion carried. Copy of bids attached and made a part hereof by references.


Chris Rivera, Tax Assessor Collector presented 2022 preliminary totals he received from the Appraisal District. He stated the appraised values are up approximately \$500 million from 2021. He stated there is a substantial growth in taxable value. Copy of preliminary totals attached and made a part hereof by references.

Motion was made by Commissioner Garcia to approve the preliminary plat of Whiskey River Sub-Division. Motion was seconded by Commissioner Cartrite. Motion carried.


Dallas Green, Road & Bridge Supervisor called and stated he could not attend the meeting. He stated they will start sealcoating Road G. Commissioner Garcia told Dallas he wanted 2 or 3 machines on those roads and get them done. Commissioner Cartrite stated he wants to make sure they get the base packed good. He would also like to begin work on the additional mile of Road D.

It appears there is no other business to come before the court. Motion was made by Commissioner Mixon to adjourn. Motion was seconded by Commissioner Garcia. Motion carried.
