Tommy Brooks, Emergency Management Coordinator presented an update on JBS testing. He stated JBS tested 1,699 people and 204 tested positive for COVID. He stated that is approximately 12% of the workforce. Copy of update attached and made a part hereof by references.

Motion was made by Commissioner Vaughan to approve the purchase of sneeze guards and use the COVID 19 grant funds to pay for the sneeze guards and any COVID 19 related items. Motion was seconded by Commissioner Cartrite. Motion carried.

Jace Delgado with the Sheriff's Dept. stated he checked with Sunray Police Dept. and Cactus Police Dept. to see if they wanted to be a part of the Law Enforcement Grant in regards to COVID. SPD stated they would not be eligible due to some reporting issues and CPD didn't feel like they would need to participate in the grant.

Motion was made by Commissioner Cartrite to approve the Interlocal Agreement between Moore County and City of Dumas 2020 Coronavirus Emergency Supplement Funding Grant(CESF) Program Local Solicitation. 




