BE IT REMEMBERED THAT ON THIS 10TH day of MARCH, 2021 there came on to be held a Special Called Meeting of Commissioners Court, in the Commissioners Courtroom in Dumas, Texas. The following persons were present to wit: County Judge, Rowdy Rhoades; Daniel Garcia, Commissioner Precinct 1; Dee Vaughan Commissioner Precinct 3 via Zoom; Lynn Cartrite, Commissioner Precinct 4; and Brenda McKanna, County Clerk.

Court having been opened according to law the following proceedings were had to-wit:

Commissioners Mixon was absent from the meeting.

The meeting was hosted by Allison, Bass and Magee, LLP to discuss the Redistricting Processes. Mr. Bass stated the process of re-districting is a Constitutional Matter under Art. 2 of the. Constitution and the constitution does apply to all units of governmental entities. He stated it allows for one person one vote and each person's vote should have the same weight as any other person voting. The reason for re-districting is to make sure districts are balanced according to the Voting Rights Act 1965. It must be done in a manner that doesn't dilute minority voters and shows no evidence of discrimination of voting. Congress will be re-visiting the Voting Rights Act 1965 but Art. 2 of the constitution is still in force. He stated local levels don't have to be an exact portion but there is only a 10% deviation allowed. Mr. Bass recommends bringing the lines as close to 2-4% as possible. He stated race can't be the pre-dominant factor in re-districting but under the Voting Rights Act 1965 it is has to be considered. When the 2020 census data becomes available, they will do an initial census data according to the census numbers. At this time the zoom meeting ended and will be continued at a later date.

It appearing that there was no other business to come before the Court at this time, motion was made by Commissioner Garcia that the meeting stand adjourned. Motion was seconded by Commissioner Cartrite. Motion carried.
