
During budget work session the Sheriff’s Office they are asking to keep two deputies in the SB 22 Funding. Judge Rhoades asked if they would be willing to purchase three vehicles out of the SB22 Funds and they stated they are not wanting to use the funds for that. It was discussed that the cost of one road grader is \$283,351.00 for the Road & Bridge Dept. There is still a deficit of \$723,850.00 and if tax rate is raised to max rate the deficit will be \$302,000.00.


