## MINUTES OF COMMISSIONER COURT, MOORE COUNTY, TEXAS REGULAR SESSION, MONDAY, JULY 8, 2024

BE IT REMEMBERED THAT ON THIS 8TH DAY OF JULY, 2024 there came to be held a Regular Session of Commissioners Court of Moore County. Texas in the Commissioners Courtroom in the Courthouse in Dumas, Texas. The following persons were present to-wit: Rowdy Rhoades, County Judge; Daniel Garcia, Commissioner Precinct 1; Miles Mixon, Commissioner Precinct 2; Dee Vaughan, Commissioner Precinct 3; Colt Farni, Commissioner Precinct 4 and County Clerk Deputy, Teresa Henry.

Court having been opened according to law the following proceedings were had to wit:

Motion was made by Commissioner Vaughan that the bills as presented by Coy Barton, County Auditor be approved for payment and the County Treasurer is hereby directed to issue warrant-checks thereof as presented by Coy Barton, County Auditor. Motion was seconded by Commissioner Farni. Motion carried.

There was one bill presented for special handling:

Motion was made by Commissioner Mixon to approve the travel expense for Amber Hokanson in the amount of \$1,341.09. Motion was seconded by Commissioner Vaughan. Motion carried.

Motion was made by Commissioner Vaughan to approve the Temporary Cash Investments dated July 8, 2024 as presented by Coy Barton, County Auditor and the County Treasurer's Report of Cash Disbursements of the same date. Motion was seconded by Commissioner Farni. Motion carried.

Motion was made by Commissioner Farni to approve transferring \$2,617.22 from insurance payment to auto expenses for repairs on an Emergency Management truck. Motion was seconded by Commissioner Mixon. Motion carried.

Motion was made by Commissioner Farni to approve the lease renewal with Pitney Bowes for the postage meter with the Tax Assessor Collector. Motion was seconded by Commissioner Vaughan. Motion carried. Copy of lease attached and made a part hereof by references.

Don Willingham, Airport Manager informed the court he had discovered some discrepancies on what is being charged on hangar rental fees. He stated there are some people who do not have to pay any fees and he didn't understand the reasoning behind the different rental fees. He feels like there needs to be some changes and everyone should be paying the same fees. He is asking the court if he can adjust the fees accordingly and send out letters to tenants that the court is going to set a standard fee for all tenants.

Motion was made by Commissioner Mixon to allow the airport manager to adjust rental rates accordingly and send out letters in regard to the rental rates. Motion was seconded by

Commissioner Vaughan. Motion carried. Copy of letter attached and made a part hereof by references.

Motion was made by Commissioner Farni to approve the purchase of a MDT(Mobile Data Terminals; in car computers) in the amount of \$3,399.00 with expenditure to be paid from the Sheriff's Office Seizure fund. Motion was seconded by Commissioner Vaughan. Motion carried.

Motion was made by Commissioner Vaughan to approve the Sheriff's Fees for 2025. Motion was seconded by Commissioner Farni. Motion carried. Copy of sheriff's fees attached and made a part hereof by references.

Motion was made by Commissioner Mixon to approve the employment of Julie Beck as a corrections officer effective June 13, 2024 with a salary of \$24.38 per hour with a \$100.00 per month clothing allowance and a .50 increase every six months for one year. Motion was seconded by Commissioner Farni. Motion carried.

Motion was made by Commissioner Vaughan to approve the employment of Veronica Landeros as the County Judge Secretary effective June 27, 2024 with a salary of \$3,688.57 per month with a \$50.00 increase every six months for two years. Motion was seconded by Commissioner Farni. Motion carried.

Raymond Tate, Road & Bridge Supervisor gave a report on the department. Raymond presented some costs to have the roof replaced at the Sunray Barn. The court wants to wait until they get the revenue reports before they make a decision on the roof repairs and or replacement. Raymond asked about the comp time for the employees. The court stated they have a standard policy and it is the responsibility of the department supervisor to regulate and monitor comp time and to make sure it is used in a timely manner and the employees are not accumulating an abundance of comp time.

During budget work session County Auditor, Coy Barton, Melissa Martinez and County Treasurer, Kara Milligan were present for the budget work session. Coy stated they should have the revenue reports by the end of the month and at that point the court will know what funds they will have to work with. The court agreed to meet on Thursday, August 1<sup>st</sup> after the revenue reports have been completed.

No further action is to come before the court, motion was made by Commissioner Farni to adjourn. Motion was seconded by Commissioner Mixon Motion carried.
