MINUTES OF COMMISSIONERS COURT, MOORE COUNTY, TEXAS SPECIAL SESSION, MONDAY, MAY 27, 2025

BE IT REMEMBERED THAT ON THIS 27TH DAY OF MAY, 2025 there came to be held a Special Session of Commissioners Court of Moore County, Texas in the Commissioner's Courtroom of the Courthouse in Dumas, Texas. The following persons were present to wit: Rowdy Rhoades, County Judge; Daniel Garcia, Commissioner Precinct 1; Miles Mixon, Commissioner Precinct 2; Dee Vaughan, Commissioner Precinct 3; Colt Farni, Commissioner Precinct 4 and Brenda McKanna, County Clerk.

Court having been opened according to law the following proceedings were had to wit:

During routine announcements and reports it was stated that the drone was used as a great resource to find a person that was wanted, due to the drone being activated the Sheriff's Dept. was able to find the person.

Motion was made by Commissioner Farni that the bills as presented by County Auditor, Coy Barton, be approved for payment and the County Treasurer is hereby directed to issue warrant checks thereof. Motion was seconded by Commissioner Mixon. Motion carried.

Motion was made by Commissioner Farni to approve the Interlocal Agreement between City of Cactus and Moore County for cost-sharing the seal coating project in Cactus. Motion was seconded by Commissioner Garcia. Motion carried. Copy of agreement attached and made a part hereof by references.

Motion was made by Commissioner Mixon to approve the purchase of a replacement computer for the tax office in the amount of \$1,878.99. Motion was seconded by Commissioner Vaughan. Motion carried.

Motion was made by Commissioner Mixon to approve the request from the Sheriff's Dept. to auction six backseats for Chevy Tahoe's and two for Dodge Chargers through Assister Auctions. Motion was seconded by Commissioner Garcia. Motion carried.

Motion was made by Commissioner Farni to approve the request from the Sheriff's Dept. to purchase vehicles this year with SB22 Funds and finance the Bearcat in May 2026 with the SB22 Funds. Motion was seconded by Commissioner Vaughan. Motion carried.

There was some discussion regarding the payment to Jeff Sumrow, Sunray CISD school resource officer for comp time and vacation pay due to his retirement. Scott Higginbotham, County Attorney stated it is in the contract that Sunray CISD is responsible for the payment of his comp time and vacation payment.

Motion was made by Commissioner Vaughan to have the Sheriff's Dept. draft a letter as per the contract and advice from the County Attorney that Sunray CISD is responsible for the payment of comp time and vacation pay to Jeff Sumrow. Motion was seconded by Commissioner Garcia. Motion carried. Copy of amount owed attached and made a part hereof by references.

Motion was made by Commissioner Mixon to approve the purchase of ladder for the airport at a cost of \$1,128.00 to be paid from the RAMP Grant. Motion was seconded by Commissioner Farni. Motion carried.

Motion was made by Commissioner Farni to approve the overtime payment to Brea Rangel and Teresa Henry for the Joint Election held on May 3, 2025 in the amount of \$294.66 with expense to be reimbursed by City of Sunray, Sunray CISD, Dumas ISD and City of Dumas. Motion was seconded by Commissioner Mixon. Motion carried.

Motion was made by Commissioner Vaughan to move the second meeting of June from June 23rd to June 30th for budget workshop and allow the County Treasurer to pay the bills as necessary. Motion was seconded by Commissioner Farni. Motion carried.

Raymond Tate, Road & Bridge Supervisor gave a report on the department. The court stated there needs to be some caliche place on Road U and Road R, also there are several potholes on Cactus Feeders Road that need to be repaired. Judge Rhoades stated he would like to have the area around the Courthouse seal coated this summer.

It appears there is no other business to come before the court. Motion was made by Commissioner Mixon to adjourn. Motion was seconded by Commissioner Farni. Motion carried.
