BE IT REMEMBERED THAT ON THIS 10th DAY OF NOVEMBER, 2025 there came to be held a Regular Session of Commissioners Court of Moore County, Texas in the Commissioners Courtroom in the Courthouse in Dumas, Texas. The following persons were present to-wit: Rowdy Rhoades, County Judge; Miles Mixon, Commissioner Precinct 2; Dee Vaughan, Commissioner Precinct 3; Colt Farni, Commissioner Precinct 4 and Brenda McKanna, County Clerk.

Court having been opened according to law the following proceedings were had to wit:

Commissioner Garcia was absent from the meeting.

During routine announcements and reports Coy Barton, County Auditor stated the outside audit will begin the first week in December.

Motion was made by Commissioner Vaughan to approve the minutes of the Regular Meeting of October 13, 2025. Motion was seconded by Commissioner Mixon. Motion carried.

Motion was made by Commissioner Farni that the bills as presented by County Auditor, Coy Barton, be approved for payment and the County Treasurer is hereby directed to issue warrant-checks thereof. Motion was seconded by Commissioner Mixon. Motion carried.

There were four bills presented for special handling:

Motion was made by Commissioner Mixon to approve the payment to Shad McDaniel in the amount of \$5,412.98. Motion was seconded by Commissioner Vaughan. Motion carried.

Motion was made by Commissioner Farni to approve the payment to Harvey Tire in the amount of \$6,900.00. Motion was seconded by Commissioner Vaughan. Motion carried.

Motion was made by Commissioner Mixon to approve the payment to Kellisa Ortega in the amount of \$91.82. Motion was seconded by Commissioner Vaughan. Motion carried.

Motion was made by Commissioner Vaughan to deny the payment to Balderrama Law Firm in the amount of \$1,000.00 since the invoice was submitted 2 years late. Motion was seconded by Commissioner Mixon. Motion carried.

Motion was made by Commissioner Mixon to approve the Temporary Cash Investments dated November 10, 2025 as presented by Coy Barton, County Auditor with no changes and the

County Treasurer's Report of Cash Disbursements of the same date. Motion was seconded by Commissioner Farni. Motion carried.

Motion was made by Commissioner Vaughan to approve the Justice of Peact Pct. 1 contract #LGS04-00121 Addendum 4, a Non-Exclusive License and Services Agreement for the purchase of two LGS licenses at a cost of \$200.00 per month. Motion was seconded by Commissioner Farni. Motin carried. Copy of agreement attached and made a part hereof by references.

Motion was made by Commissioner Farni to accept the Adult Probation finalized budgets FY26-27 and statement of financial position for the year 2025. Motion was seconded by Commissioner Mixon. Motion carried. Copy of budgets and statement attached and made a part hereof by references.

Motion was made by Commissioner Mixon to approve the District Attorney's office authorization to enter into an agreement with Axon Enterprise for the purchase of Tasers in the amount of \$1,592.34 per year for five years with expenditure to be paid from the Investigative Equipment Account. Motion was seconded by Commissioner Farni. Motion carried. Copy of agreement attached and made a part hereof by references.

Motion was made by Commissioner Farni to approve the District Attorney's office authorization to enter into an agreement with Axon Enterprise for Evidence.com software in the amount of \$10,917.88 per year with expenditure to be paid from the Data Processing Account with the agreement to begin October 2026. Motion was seconded by Commissioner Vaughan. Motion carried. Copy of agreement attached and made a part hereof by references.

Motion was made by Commissioner Mixon to approve the District Attorney's office the purchase of six computers in the amount of \$8,249.50 to ensure compliance with Windows 11 with expenditure to be paid from Office Supplies. Motion was seconded by Commissioner Vaughan. Motion carried.

Motion was made by Commissioner Mixon to approve a contract with Hutchinson County for out-of-county housing at a cost of \$60.00 per day. Motion was seconded by Commissioner Vaughan. Motion carried. Copy of contract attached and made a part hereof by references.

Motion was made by Commissioner Farni to approve the employment of Seth Bartels as Patrol Deputy effective November 4, 2025 with a starting salary of \$30.71 per hour with a .50 increase every six months for one year with a \$100.00 per month clothing allowance. Motion was seconded by Commissioner Mixon. Motion carried.

Motion was made by Commissioner Vaughan to approve the Down and Dirty Ditching water line permit on Buddy Kline Road Sec A-182 & A-1253 in Precinct 3. Motion was seconded by Commissioner Farni Motion carried. Copy of permit attached and made a part hereof by references.

Motion was made by Commissioner Farni to take "No Action" and wait until next budget cycle to consider concrete work at Meals on Wheels and consider an alternative route for the

volunteers to pick-up meals. Motion was seconded by Commissioner Mixon. Motion carried. Copy of bids attached and made a part hereof by references.

Motion was made by Commissioner Vaughan to approve the Moore County Airport AWOS renewal agreement. Motion was seconded by Commissioner Mixon. Motion carried. Copy of agreement attached and made apart hereof by references.

Motion was made by Commissioner Vaughan to table the 2025 Amended Material Lease until Commissioner Garcia is present to discuss contract. Motion was seconded by Commissioner Mixon. Motion carried.

Raymond Tate, Road & Bridge Supervisor gave an update on the department. Raymond got some quotes on flashing signs to place at the end of Schuman Road where it dead ends. There were several different suggestions to try to make people aware of the dead end but at this time nothing was decided. Raymond stated City of Cactus has mowed several roads for the county.

It appears there is no other business to come before the court. Motion was made by Commissioner Vaughan to adjourn. Motion was seconded by Commissioner Mixon. Motion carried.
