Judge Rhoades declared the meeting open for a public hearing at 9:33 A.M. in regards to placing yield signs at the intersection of Light Plant Road and Road E. There was no public comment. Judge Rhoades declared the hearing closed at 9:35 A.M. and opened the meeting in regular session.

Coy Barton, CPA presented his Independent Auditor's Report. Copy of report attached and made a part hereof by references.

Motion was made by Commissioner Cartrite to approve the employment of John Fisher as Deputy Sheriff effective January 14, 2019 with a salary of \$25.28 with a .50 increase every six months for one year and a \$100.00 per month clothing allowance. Motion was seconded by Commissioner Vaughan. Motion carried.

Motion was made by Commissioner Garcia to approve the transfer of Jace Delgado from Deputy Sheriff to Investigator effective January 2, 2019. Motion was seconded by Commissioner Mixon. Motion carried.

Motion was made by Commissioner Vaughan to approve a letter of appreciation and support for Senator Kel Seliger. Motion was seconded by Commissioner Garcia. Motion carried. Copy of letter attached and made a part hereof by references.

Travis Smith, Road & Bridge Supervisor gave a report on the department. There was some discussion in regards to the county doing the ground work for a Greg Smith Memorial to be located at the south end of Sunray which would cost approximately \$1,700.00 for employee time and use of equipment. Judge Rhoades stated he wouldn't want to do anything like that without an Interlocal Agreement in place and would need to visit with the City Manager of Sunray.
